- Submit copies of invoices for AMVAC qualifying product purchases with the incentive submission form by July 31, 2021.
- AMVAC qualifying purchases must be made and submitted each year in 2021, 2022 and 2023.
- Incentives of up to 1/3 of SmartBox System purchase price can be earned each year in 2021, 2022 and 2023.

## Growers Must Submit a SmartBox Registration and Agreement Form – 2021 Season

Growers participating in the Standard SmartBox Purchase Program or the Discounted Pre-Shipment Payment Option in connection with purchase of a NEW SmartBox System for first-use in the 2021 crop year are eligible to earn incentives of up to ½ of total SmartBox purchase price paid. Grower must purchase and submit copies of invoices of AMVAC qualifying products from an authorized AMVAC retailer in each of the years 2021, 2022 and 2023 to earn the incentive. Incentives cannot exceed ½ of total SmartBox purchase price each year.
