2022 AMERICAN INNOVATORS AWARD SWEEPSTAKES OFFICIAL RULES

NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW. The AMGUARD Environmental Technologies 2022 American Innovators (the “Sweepstakes”) begins on or about *February 5, 2022* and ends on *June 30, 2022* (“Sweepstakes Period”).

1. **Eligibility.** The Sweepstakes is open to legal U.S. residents, who are older than 18 or the age of majority in their state. AMGUARD employees, officers and directors, their immediate family members (spouse, siblings, children and parents, regardless of where they live), affiliates, subsidiaries, advertising and promotion agencies and those entities associated with the development, distribution or implementation of this Sweepstakes are not eligible to participate.

4. The following information is mandatory for a nomination to be considered: title, email, company name, industry, category, nominee name, nominee email and a max 300 word description on why the nominee should be the 2023 American Innovator. A max upload of two photos is optional.

Limit one (1) entry per person, regardless of the form of entry. All entries become the property of AMGUARD and will not be acknowledged or returned, and no correspondence will be entered into regarding the status of any entry. Entries that do not comply with the terms of the Sweepstakes will result in disqualification. Incomplete or illegible entries will not be considered. This program is subject to change without notification at AMGUARD’s sole discretion. Entries will be void if electronically or mechanically reproduced, forged, defective, altered or obtained through unauthorized channels or if they contain production, typographical, electronic, mechanical or other errors. AMGUARD reserves the right in its sole discretion to disqualify any entry at any time which, in AMGUARD’s opinion, is offensive, contains unsuitable material, endangers the safety or wellbeing of any person, or if it is determined the entrant has not complied with these Official Rules.

If the Prize or any portion thereof cannot be awarded for any reason, AMG UARD reserves the right to substitute such Prize with another Prize of equal or greater value. Once the winner is selected, an AMG UARD representative will reach out via the email associated with the registration and confirm a physical delivery address. The Prize will be delivered to the home address associated with the winner's online or booth Sweepstakes registration. Allow 2-4 weeks for outreach delivery.
