



## DIBROM® CONCENTRATE and TRUMPET® EC 2021 NATIONAL DRUM RECYCLING PROGRAM

As part of our product stewardship program, AMVAC Environmental Products has contracted with Container Services Network (CSN) to manage all logistics for the recycling of your empty DIBROM® CONCENTRATE and TRUMPET® EC drums.

This service is provided by AMVAC Environmental Products at no additional cost to you, provided the following requirements are met and all steps are completed accurately. Thank you for your cooperation and trust in AMVAC Environmental Products.

Step #1 – Select your drum count and organize your load for inspection.		
Drum Count	Requirement	Important!
8-12	Not Palletized – loaded as singles	8 is the <u>minimum</u> drum quantity permitted
13-99	Palletized – Up to 4 drums per pallet	Shrink wrap to support pallet stack loading
100 +	Not Palletized – loaded as singles	

Step #2 – Prepare your drums for carrier inspection, loading and recycling	
Requirement	Important!
Verify that ALL drums weigh 29 lbs. <b>or less</b>	By design, an "empty" drum will weigh between 26-29 lbs.
Verify both drum openings are sealed and snug	Drums with missing bung plugs/valves will not be picked up
Stage all sealed, and weight approved drums	The carrier will require clear access for safe loading

Step #3 – Send one email to CSN at: <a href="mailto:logistics@containerservices.com">logistics@containerservices.com</a>
<b>Your email must include:</b> AMVAC drum count, the detailed pick-up address, your requested pick-up date, your hours of operation for receiving trucks, a contact name and mobile number (preferred).

Step #4 – Receive your Bill of Lading (BOL)
Within 24 hours, by return email, you will receive a one-page Bill of Lading. This document includes all details related to your load. Remember, unsealed or overweight drums, or a quantity error, will void the BOL and require the process to be repeated. Finally, PRINT the BOL and have it ready for hand delivery to the driver upon arrival. Unless otherwise requested, pickups will be scheduled for 2 business days after your BOL is provided. We ask that you remain flexible during this stage as the scheduling of preferred carriers can depend on the availability of trucks and drivers. Keep in mind, for 12 or less drums, the LTL truck will usually arrive in the afternoon. Please arrange for someone to be as late as 4 PM. If this is not possible, special arrangements can be made with CSN.
